FIRE PREVENTION FEE SCHEDULE

Effective July 1, 2017

**Return check fee is \$50.00*

Operational Permits* - Permits to operate an occupancy or use of special hazards:

- Ambulatory Health Care Clinic: \$50.00
- Day-Care Centers: \$50.00
- Explosives, use and storage: \$60.00
- Fireworks, sale and storage of consumer: \$250.00
- Flammable Liquid Storage (Gas Stations): \$150.00
- Health Care Facilities: \$50.00
- Hotels: \$50.00
- Hot Work Permits: \$40.00
- Places of Assembly (restaurants, special amusement buildings)
 - Liquor: \$100.00
 - Non-liquor: \$50.00
- Residential Board and Care: \$50.00
- Business Facilities (Outpatient Clinics): \$50.00
- Pyrotechnic/Flame Effects/Fireworks: \$50.00
- Special Outdoor Events (includes fairs, carnivals, or other events): \$50.00
- Temporary Tents over 400 sq. ft.: \$25.00 per tent for 1st tent, \$5.00 per tent thereafter
- Temporary Liquor Licenses: \$25.00

- Basic with Investigator's Report and Photos: \$275.00

Rapid Entry Key Lock Box System ("Knox Box")*

- Application: \$100.00
