

This is to certify that at a meeting of the Court of Common Council, February 23, 2009, the following RESOLUTION was passed.

WHEREAS, Nancy M. Mulroy has provided media and communications professional services to the Hartford Police Department since September of 2003; and


WHEREAS, In 2007 the City of Hartford entered into a professional services contract with Nancy M. Mulroy to provide media communications professional services to the Hartford Police Department from January 1, 2008, through December 31, 2008, with a provision of three one-year renewals; now, therefore, be it

RESOLVED, That the Mayor and Court of Common Council hereby authorizes the extension of a one year renewal of the personal services contract between the City of Hartford and Nancy M. Mulroy to provide media and communications services to the Hartford Police Department; and be it further

RESOLVED, That inasmuch as the City of Hartford is currently facing fiscal challenges, Ms. Mulroy's hourly rate will be reduced from \$40.00 per hour to \$35.00 per hour and work week from 40 to 35 hours, not to exceed 45 work weeks in 2009, reflecting both a reduction in hourly rate, hours per week, and weeks per year; and be it further

RESOLVED, That Ms. Mulroy's one year contract renewal is for the period of January 1, 2009, through December 31, 2009, at an hourly rate of \$35.00, for 35 hours per week, for 45 work weeks, not to exceed \$55,125.
