This is to certify that at a meeting of the Court of Common Council, March 14, 2011, the following RESOLUTION was passed.

Whereas, Trans fats are the common name for unsaturated fats with trans-isomer (E-isomer) fatty acid(s); and

Whereas, Consumption of trans fats increase the risk of heart disease, the leading killer of Hartford residents; and

Whereas, While the City of Hartford and its residents have made significant progress towards increasing its wellness and practicing healthy lifestyle regiments through the Healthy Hartford campaign, many continue to consume trans fats because they are unaware of their presence in foods; and

Whereas, People have cooked with trans fats for over a hundred years, but in light of recent research illuminating the dangers of their consumption, many jurisdictions have either banned products containing trans fats or mandated that food establishments disclose their presence; now, therefore, be it

Resolved, That the Court of Common Council requests that the Mayor and Chief Operating Officer, in conjunction with Health and Human Services Department, submit an ordinance banning or restricting the sale of products with trans fats in Hartford to the Court of Common Council within ninety (90) days of the passage of this resolution.


